## **Presenter Bios:**

The webinar presenters will share pivotal moments in their braided journeys toward epistemic freedom in Canada and South Africa, from First Nation, African, and White Settler positionalities. They will describe their respective origin stories, and how their relationship to their positionality and purpose has evolved with their relationship to their practice to generate and mobilize evidence for transformational change. Presenters will engage online participants to explore how mental, emotional, spiritual, and physical dimensions of relationality influence culturally responsive inquiry. Referencing the recently launched <u>Wolastog</u> <u>Declaration</u>, they highlight how epistemic freedom underpins relationality with all of creation.

<u>Prof Fayth Ruffin's</u> expertise is centred on curricula design, delivery and transformation driven by ongoing evaluation and assessment. Her forthcoming 2025 book is entitled <u>Navigating Manifestation</u>: A wounded healer's approach to spiritual consciousness'. It invokes courageous conversations about epistemic freedom and traces the role of her ancestors and the forces of nature in her trajectory over three careers in law, public governance and higher education. Keynote addresses and conference papers have been delivered across four continents and ten countries. Prof's interactive workshops and seminars promote indigenous knowledge systems that speak to our authentic selves.

Stephanie Francis, a member of Sitansisk or St. Mary's First Nation, near Fredericton, is an Indigenous social worker on the east coast. She has many years of experience working on the front lines in both Mi'kmaq and Wolastoqiyik communities throughout the Maritimes. Coupled with a Bachelor of Arts and a Bachelor of Social Work, Stephanie has been able to learn a unique skill set in translating Indigenous knowledge and worldview while honouring the spirit of the teachings from those whom she has come across on her life's journey. By creating her own business called Spirit First, she has been able to establish services with a Spirit First approach. She can also provide services and guidance to organizations that want to become "trauma-informed" and be a safe space for their Indigenous employees.
